### **School History**

Founded in 2007, Prairie Adventist Christian eSchool (PACeS) is part of the Seventh-Day Adventist (Adventist) educational system. The Adventist educational system is the largest Protestant Christian education system in the world and has been in existence for over a century. It is supervised by the Alberta Conference of Seventh-day Adventists Office of Education. PACeS is part of the Seventh-day Adventist educational system, which operates 7,200 schools worldwide with a total enrollment of over 1.5 million students. Our school has the experience, accreditation, and dedication to provide accessible Adventist Education, wherever you are.

### **What is PACeS Home Education?**

At PACeS we offer a parent-directed program called Home Education. In Alberta, parents have the opportunity to take control of their students' education by registering their student as a supervised or unsupervised student. Here at PACeS we offer supervision as you take on the responsibilities of teaching your students.

### **Benefits Of Home Education At PACeS**

### **Adventist Foundations and Supports**

As a Seventh-day Adventist institution we aim to support our families as they grow in their personal relationship with Jesus.

#### **Parent-Facilitator Collaboration**

To help families stay on track with their program plan, we set up a minimum of 2 meetings per year.

These meetings generally include:

- Initial "Hello!" introductions
- Program plan review
- Portfolio of evaluations and celebration of learning

### **Ongoing Access to Facilitator Support**

Our facilitators are available for consultations at any time in the school year (September to June)

### **Learning Resources**

You have the opportunity to choose your own learning materials for your student's plan. PACeS also offers access to Mathletics, RAZ Kids, the Canadian Reader and What in the World?

### **Home Education Funding**

The Government of Alberta provides up to \$901 for students that are under the Home Education Regulation (parent-directed program) and Shared Responsibility (online program and parent-directed program) and enrolled with PACeS by September 29.

Alberta Education provides up to \$901 for students enrolled in grades 1-12 under the Home Education programming, and it provides \$450.50 for students enrolled in the Kindergarten Pilot Home Education Programming.

### **PACeS Events**

Throughout the year PACeS organizes optional events for Home Education families to participate in. Expenses for each activity vary.

Some events may include activities like:

- Calgary SPARK Science Centre
- Outdoor Park Day
- Recreation Center Day
- Museum Visit

### **Shared Responsibility**

This is the best of both our PACeS worlds! At times, families are interested in a combination of our Home Education Program (parent-led programming) and our Online Program (teacher-led programming). Shared Responsibility gives the families the opportunity to take part in both.

### **IMPORTANT DOCUMENTS**

<u>Alberta Home Education Handbook</u>: Alberta Education has created a handbook to help you as you prepare for your family's adventure in home education, you can access it using this linked document.

Home Education Regulations: This link takes you to the Home Education Regulations provided by the province. This is for you, the parent, to follow as a Home Educator with assistance from the responsible school (PACeS). These regulations help guide families through the expectations in the Alberta Home Education Handbook. It also helps to ensure that the responsible School Board is working with parents to succeed in implementing the guidelines for Home Education.

### PARENT AND PACES HOME EDUCATION RESPONSIBILITIES

To ensure a successful school year for our Home Education students we have highlighted a few responsibilities for both PACeS and Parents.

### **Parent Responsibilities**

- Communicate and cooperate with the school
- Notify the school of their intent to home educate yearly (application)
- Refer to the Alberta Home Education Handbook in preparation and creation of the Home Education Program Plan
- Choose resources and activities that help the student achieve the chosen learning outcomes
- Administer and manage the home education program plan
- Maintain samples of completed student work and a record of activities throughout the year
- Maintain a record of evaluations to help monitor the students progress
- Meet a minimum of 2 times per year with their facilitator to collaborate and evaluate the student's progress

### **PACeS** Responsibilities

- Communicating and partnering with parents
- Providing a certified teacher/facilitator to help monitor and support parents with the program plan
- Provide resources, advice and assistance to the parent upon request to help with student learning
- Meet with parents to evaluate the student's progress by reviewing the student's collection of work (ie. portfolio)
- Meet with parents to help students achieve the learning outcomes as defined be the Home Education Regulation

### **DESIGNING A HOME EDUCATION HOME ED PLAN**

### 4 Questions you can start asking yourself:

- 1. What are your goals?
- 2. What do you plan for your child to learn?
- 3. How do you plan to help them learn?
- 4. How will you know they have learned?

### Let's dig into these questions a little deeper:

### 1. What are your goals?

There are many approaches to home education. We offer the opportunity to have Home Education programming where you decide to keep the responsibility to educate your child. We also offer Shared Responsibility Programming, where you decide to share the responsibility with PACeS Online. Either one is a great option. The choice you make will be the one that fits with your family the best.

# 2. What do you plan for your child to learn? What program of study will you use to develop your plan?

There are two options to choose from:

- 1. <u>The Alberta Program of Study</u> where Alberta has given a list of skills and knowledge or outcomes the students should learn at different grade levels.
- 2. The other option is to follow the list of skills and knowledge or outcomes from the Schedule of Learning Outcomes for Students Receiving Home Education Programs That Do Not Follow the Program of Study listed on page 10 and 11 of the Home Education Regulations.

### 3. How do you plan to help them learn?

Begin brainstorming about the WHAT and the HOW you want your children to learn the outcomes program you have chosen.

### What resources will you use?

- Print resources (IEW, Math U See, Donna Ward, worksheets...)
- Human Resources (special guests, specialist, tutors)

- Electronic Resources (internet websites, dvds, audio books, digital games)
- Community Resources (museums, community programs, neighbours)

### What learning activities will help your child learn?

There are so many ways to use to help others learn, here are some ideas:

- Read material and respond to questions
- Compose and prepare a variety of written responses
- Complete research
- Work with others to complete a task
- Use media and Internet resources
- Prepare and deliver formal talks, presentations, and dramatizations

- Complete experiments
- Chores
- Participate in organized field trips
- Special guests
- Internet websites
- Printed textbooks/curriculum
- Classes outside the home
- Field trips
- Community programs
- Church
- Neighbours
- Outreach program

You may have specific interests that you want to explore or major projects that you want to use throughout the year. Having the learning outcomes in mind at the beginning of the year will help you to stay on track and meet the expectations of the Home Education Regulations.

# 4. How will you know they have learned? How will you evaluate your child's learning?

In general, student learning can be evaluated in two ways:

- Students respond with a predetermined correct answer or students respond in writing or through oral presentations, demonstrations, problem solving activities and dramatizations,
- Students run something, build something or create something.

As an evaluator, think about WHAT outcomes are in focus and HOW you will evaluate them.

Here is a list to help you think about how you wish to evaluate:

- Assess the student by having them respond to a predetermined correct answer:
  - Short oral or written answer
  - o Multiple choice
  - True/false
  - Matching
  - Numeric response
  - Unit tests
- Assess the student on quality of written compositions, problem solving and oral presentations with a form that highlights important features in their work

- Quarterly Reports
- Journal or anecdotal notes by parent
- important features in their work
- Discussions
- Recital
- Project creations (models, posters, experiments)
- Parent observation

Another good question to start thinking about is whether or not you are planning on taking the opportunity to have your student participate in assessments being offered here at PACeS. We provide opportunities for families to take part in the Alberta Provincial Achievement Tests (grade 6 and 9), the Student Learning Assessment (grade 3) and the Canadian Achievement Test (grade 1-12).

I hope that looking at these elements while planning for the new year has sparked excitement and also helped to clarify or answer questions you may have had. Having this information ready for when you submit your application will help you fill out your student's program plan on the form with more ease.

### FREQUENTLY ASKED QUESTIONS

# 1. What is the difference between your Online Program, your Home Education Program and your Shared Responsibility Program?

**PACeS Online** is a synchronous **teacher-led** program. This program is designed to teach students online, with one of our excellent teachers planning for your student's learning according to the Alberta Program of Study. They are teaching your student in a live session. The teacher monitors your student's learning and evaluates their progress.

**PACeS Home Education** is a **parent-led** program where the parent is planning their student's learning according to either the Alberta Program of Study or the Outcomes in the Alberta Home Education regulations. The parent is teaching their student, evaluating their student and tracking their student's progress under the supervision of our wonderful certified teacher facilitators.

**PACeS Shared Responsibility** is a combination of both the **teacher-led** program **and** the **parent-led** program. Both PACeS Online and PACeS Home Education work in partnership for the student's learning goals.

### 2. How does Shared Responsibility work?

A student can be enrolled in both programs, Online and Home education, with Online courses being between 20% - 80% of the student's program. The parent decides which courses they will teach through PACeS Home Education and which courses they would like PACeS Online to teach.

In the PACeS Shared Responsibility Program, the following options are available, where the percentage indicated in the table is the portion of the program for which PACeS is responsible:

#### **Grades 10-12**

High school students can take anywhere from 20% to 80% of a full time student load in a shared responsibility program. The percentage of the online education program is calculated by dividing the number of credits taken by 35 (a full time student load).

## 3. What if I want to transition from Home Education to Shared Responsibility or Online during the school year?

For grades 1-9 a change of program after September 30th from:

- Home Education to Shared Responsibility or Online: Tuition will be \$700.00/class
- Shared Responsibility to Online: Tuition will be \$700.00/class
- Any transitions in Grade 10-12 must be approved by school administration and must happen during specified time periods.

## 4. Can my Home Education High School student enroll into level 20 or 30 courses without having completed level 10 courses?

Yes. However, students are highly encouraged to join PACeS Online for High School in grade 10. This ensures that they will receive the required credits and prerequisite courses for them to complete a high school diploma. Students who wish to take courses outside of this recommended sequence would need administrative approval.

### 5. Do I have to follow the Alberta Program of Study?

In Alberta, parents are given the option to either follow the Alberta Program of Study or the Learning Outcomes for Students Receiving Home Education Programs that do not Follow the Alberta Programs of Study.

# 6. What is the difference between the Alberta Program of Study and the Learning Outcomes for Students Receiving Home Education Programs that do not Follow the Alberta Programs of Study?

**The Alberta Program of Study** is a set of learning outcomes that Alberta has assigned for every grade level and subject. Teachers use it as their foundation for planning in the classroom.

The Learning Outcomes for Students Receiving Home Education Programs that do not Follow the Alberta Programs of Study is a set of 20 outcomes that home educators can use to develop a program with a bit more freedom on what to study. These can be found on page 10 on the Home Education Regulations.

### 7. What is PAT and CAT testing?

PATs are <u>Provincial Achievement Tests</u>. "Provincial Achievement Tests (PATs) are administered annually to all Alberta students in grades 6 and 9. These standardized tests reflect the essentials that all Alberta students are expected to achieve, regardless of school choice or location." These tests assess the student in their grade level according to the Alberta Program of Study Objectives.

SLA's are <u>Student Learning Assessments</u>. "Student Learning Assessments (SLAs) are digital tests administered at the beginning of the school year in Grade 3. They assess outcomes related to literacy and numeracy in language arts and mathematics."

CATs are <u>Canadian Achievement Tests</u>. "The CAT is a testing system that assesses the essential learning outcomes of the following basic skill areas: reading, language, spelling, and mathematics." These tests are completed at the grade level requested by the parents.

### 8. Does my student have to take the SLAs, PATs or CATs?

No. Your student does not have to take these tests. We do recommend the CATs at times for those who want to:

- 1. Give their student's the experience of test taking
- 2. Give the parents an idea of where their students may need more focused learning activities.

### 9. Can my child earn an Alberta High School diploma by completing 12 years of PACeS Home Education?

No. Unlike our Online Program, Home Education students with PACeS cannot earn a diploma. There are options with other boards to have the opportunity to earn a diploma, at this time PACeS does not offer this option in the Home Education and Shared Responsibility Programs. However, if a student joins our Online Program in Grade 10 and completes through Grade 12, they can earn an Alberta High School Diploma.

### 10. When can my student start PACeS Home Education?

"Kindergarten students must be at least four years and eight months old, and no older than six on September 1 of the year they are to start kindergarten." (See question 17.)

A student can be enrolled into **grade 1** Home Education if they are 6 years of age by September 1 of the year of enrollment.

### 11. What curriculum resources do I use?

There are many different ways to administer education. Your goals and your methods of education will influence which curriculum resources work best for you. We have compiled a <u>list</u> of different resources for you to be able to choose from but please don't limit yourself by only using what we provide. The internet has MANY different blog posts, YouTube videos, and podcasts that can help you decide what is best for you and your student. Don't hesitate to ask your facilitator questions too! They will be happy to share their experiences with you.

### 12. How many times am I required to meet with the home school facilitator?

You are required to meet with your facilitator at least 2 times per year in the student's home or at a mutually agreeable location.

### 13. What does a Home Education visit look like?

We love to come and celebrate your student's learning. The first visit is an opportunity for families to get to meet with their new facilitator or say "Hi again!" to their returning facilitator. The visit is a time for students to celebrate the different things they have learned so far, for parents to share the different observations, and evaluations they have made in their student's learning and also it is a time to check and see how the program plan is working for the student. The parent has the opportunity to ask questions, share how things are going and receive help from the facilitator to problem solve if needed. On the second visit, we are taking time to celebrate the yearly learning and growth of the student. During this visit we take a look at the overall learning samples of the year that took place. We also look at the different assessments and discuss parent observations and dated evaluations that were completed throughout the year. The second visit is also a great time to ask questions and prepare for the new year.

### 14. Are there events where PACeS families can get together?

Yes! We are always looking for ways to get our families together. In the past, we have gotten together for potluck lunch, to experience the Science Centre or play at the Recreation Complex. We aim to do a gathering every 6-8 weeks. Watch the calendar and your emails for upcoming events.

### 15. What resources are available?

Mathletics, RAZ Kids, the Canadian Reader and What in the World? We also provide a <u>list</u> of curriculum resources you can use.

### 16. How can I use my allotted funding?

Before submitting a funding claim form, please make sure that:

- you qualify for funding (home education parent-led programming or shared programming)
- the items purchased are related to your student's plan and have been added to the reimbursement column of your student's plan
- that you have receipts available for the items being claimed

### How do I receive my full funding amount?

If claims are submitted with qualifying receipts for a total of 75% of the allotted funding amount the student will be issued a reimbursement of their full allotted amount. For example if the student's full allotted amount is \$901 and their qualifying receipts add up to \$675.75, we will send the family \$901.

### When can I submit a funding claim?

Funding claims can be submitted starting Oct 1, 2025. Home Education Funding receipts for the 2025-2026 school year should be submitted by April 30, 2026. These receipts must be dated between May 1, 2025 to April 30, 2026 and must apply to the 2025/2026 program plan in order to qualify. However, Alberta Education will allow parents up to two years to access Home Education funding but any receipts submitted to PACeS after the April 30, 2026 deadline may not be processed until after October of 2026.

Home Education Funding receipts for the 2024-2025 school year can still be submitted using the 2024/2025 Funding claim form. These receipts must be dated between May 1, 2024 to April 30, 2025 and must apply to the 2024/2025 program plan in order to qualify.

### What items qualify for funding?

- Consumables paper, pencils, art supplies, general workbooks, ink
- Curriculum-based workbooks, textbooks, reading books
- Online curriculum programs learning programs on CD, digital downloads
- Learning aids manipulatives (supported in the program plan)

- Computers, technology equipment (i.e., printers), including repairs and upgrades
- Internet services (per household) 50% of monthly fee from September to end of August
- Tutoring Group or individual lessons necessary for the student's program delivered by a subject matter expert who is not an immediate family member
- Lessons including, but not limited to, music, swimming, and language lessons taught by a certified instructor and in relation to the student's program
- Tangible assets e.g., cameras, telescopes, musical instruments, physical education equipment, sewing machines
- Home economic edibles
- Admissions/field trips (up to a maximum of 50% of the funding provided to parents) – Ensure reimbursements are for activities related to the student's program, which may include zoo admission, theater tickets related to literature study, museum admissions, science center entrance fees, and multi-use recreation centers
- Multiple admissions or annual passes are acceptable for activities when directly related to the student's home education plan. Reimbursement for parent admissions and travel costs are not acceptable.
- Postage/shipping and handling from vendors to the home education family

### What items do not qualify for funding?

- Furniture
- Warranties/insurance
- Competitions including, but not limited to, swim meets and tournament costs
- Registration fees including, but not limited to, sports teams, community leagues, and summer camps
- Per Section 7(4)(b)(ii) of the Home Education Regulation, reimbursements to parents are not acceptable for personal remuneration and payment for travel costs or other expenses usually required to be paid by a parent of a student who is enrolled in a school operated by a board or private school.

### What should be on my receipt to qualify for reimbursement?

- On your receipt, you must be able to see:
  - vendor name, business license/GST registration number, or if purchased through kijiji or marketplace, the name of the person along with their contact info – address, phone # and email

- if a service provided we will need a description of the service provided, who it was provided to, when it was provided and the amount along with the name of the person providing the service along with their contact info – address, phone # and email
- evidence that the amount has been paid and when. We should have the signature of the one who received the payment but if that's going to be hard to get, then attaching the e-transfer receipt or canceled CK as proof of payment works
- date (we will only process receipts dated from May 1, 2025 to April 30, 2026)
- o items purchased
- o proof of payment: Visa, Master Card, Debit, Cheque or Cash
- total of purchase
- Mastercard/Visa statements do not qualify as receipts.
- Receipts must have only educational items listed. Receipts with personal and/or household items on them will not qualify for reimbursement.
- The items on the receipt must be related to your student's plan and have been added to the reimbursement column of your student's plan. One receipt per pdf document

### What if I purchased something from a private seller ex. Marketplace or Kijiji or Music Lessons?

If you purchase an item from Marketplace or Kijiji or have a Music lessons, you will need to make sure to get a receipt with:

- the date
- the seller's name
- The seller's phone number
- The description of the item
- the amount paid for the item
- The seller's signature

### What if my receipt is not in Canadian Funds?

For anything that is not in Canadian funds, you will need the Visa/Mastercard statement showing the amount you paid in Canadian dollars. If that is not available, you can use <a href="https://wwwl.oanda.com/currency/converter/">https://wwwl.oanda.com/currency/converter/</a> as proof of currency for the day of purchase.

• click on the website link, adjust the **currency** and **date** boxes, and then select the print link on the top left corner of the gray box (under Currency

Converter). This will take you to another page and will open the print dialog box where you can choose to save as PDF.

### **How do I submit my internet receipt?**

You can claim 50% of your monthly internet fee for the entire year in one go. Scan all the pages of your September internet bill, multiply the internet portion of your bill by 12 months, divide the total by 2 and submit that amount when filling out your form.

### What do I do if I have multiple students using the same receipt?

If you have a receipt where different items apply to different students, please be sure that the items are properly labeled with the students initials next to the item that applies to that student, and with the total amount you wish to have reimbursed for that student.

#### **Splitting Specific Items**

For bigger ticket items, we completely understand if some items are split, as at times this helps to balance out the students used/unused funding. When submitting these receipts, please be sure to label and give the specific amounts you wish each student to claim.

For smaller ticket items such as a book being used by many students, the item does not need to be split by all the students using it, it can be claimed by just one of the students. For example, If "Owls in the Family" is purchased, and all the students in that home will be using the book in the year, the book total does not need to be divided and claimed between all the students. It is absolutely fine that it is reimbursed only for the one student. This will make submissions a little easier for you.

### What if I am enrolled in the Shared Responsibility Program?

The Funding available for Shared Responsibility is equal to the percentage of the program for which the parent is responsible. For example, choosing Grade 3 LA/Bible would result in student funding of 70% of \$901, or \$630.70. A high school student taking 7 credits with PACeS (7/25 = 20%) would receive parent funding of 80% of \$901, or \$720.80.

### **How do I submit receipts?**

Before submitting the receipt please make sure that you:

qualify for Home Education Funding
$\square$ have checked that your <u>receipts</u> have the proper information on them
☐ have labeled the receipts properly if <u>splitting receipts</u> with multiple students
☐ have ALL your PDF files ready (one receipt per PDF document and <u>proof of</u>
<u>currency</u> )

Receipts can be submitted using the Home Education Funding Claim Form.

### 17. Can you tell me more about the Home Education Kindergarten Program?

The supervising school authority and legal guardians of the children will each be eligible for \$450.50 per child. Most kindergarten programs are provided on a half-day basis, so this rate is half of the full-day rate for home education for other grades.

### **Eligibility**

To be eligible for funding, kindergarten students must be:

- at least four years and eight months old, and no older than six on September 1 of the year they are to start kindergarten (birthdate prior to Jan 1, 2021)
- a resident of Alberta
- registered with a supervising school authority before September 29
